of John Glover Snr by me -----  
made this 31<sup>st</sup> of July 1834 -----

In the Following manner to wit,

- fst I give & bequeath to my beloved wife  
Barshaba Glover one feather bed & furniture  
of her own choice one Blaze mare two cows  
one yolk of oxen cart & wheels & one clock  
& calfs ^ one sow & six shoats two yews and lams  
one loom & gear one spinning wheal & cards  
one linen wheal one pine chest one pine table  
one half Dozen setting chears one Pot & hooks one  
oven one spider - Also one years provision -----  
sufficient for her & family -----
- Itm I give & bequeath to my beloved son Kelly Glover  
the sum of five dollars to be paid him by my Exetor [sic]
- Itm I give & bequeath to my beloved Daughter Sintsey  
& one desk & Buok Case  
Matthews one cow & yearling ^ -----
- Itm I give & bequeath to my beloved Daughter Aney  
Young the sum of ten dollars to be paid her  
In money -----
- Itm I give & bequeath to my beloved Son Thomas  
Glover the sum of five dollars to be paid him  
In money -----
- Itm I give & bequeath to my beloved Son John Glover Jnr  
the sum of five dollars to be paid him in money
- Itm I give & bequeath to my beloved Son Caswell  
Glover the sum of five dollars to be paid him  
in money -----
- Itm I give & bequeath to my beloved Daughter Mary  
Joiner the sum of ten dollars to be paid her  
in money -----

- Itm I give & bequeath to my beloved Daughter Sarah Rose one feather bed and furniture one cow & calf formerly coald [?] hern [?] one Ewe & lam -----
- Itm ~~Also~~ I leave one Tract of land on the north side of tariver [Tar River] to be sold on a credit of six months and the profits their from to be given to my beloved son Hilliard Glover -----
- Itm I give bequeath to my beloved Daughter Jinsey Glover one feather bed & furniture one chestnot filley one cow & calf one Ewe and lam one pine chest one pine table one sow and piggs one Pot -----
- Itm I give & bequeath to my beloved son Peyton Glover one stud [?] Coalt Bridle & saddle -----
- Itm I lend my beloved wife Barshaba Glover my negro girl named Hanah during her nattural life & after her [death] to be sold and the money arising from the sale there of to be Equally [divided] between my two Daughters Sarah Rose & Jinsey Glover
- Itm I leave my negro man nash to be sold on a Credit of six months and the money ariseing from the sale their of after paying my gust [just] debts and satisfying my Exetors I leave to be Equally divided between my Eight Children --- to wit -- Kelley Glover Sinthey Matthews Aney Young Thomas Glover John Glover Jur Caswell Glover Mary Joiner & Hilliard Glover -----

I leave all the balance of my property which I have not named in will I leave to be sold on a Credit of six months and the money arising their of after paying my sd Children their legsie [legacy?]
